

Lincolnshire Police Priority Setting Meetings 2023 Quarter 1 Update

South Kesteven Neighbourhood Policing Area

Over last year North and South Kesteven have supported the Parishes Policing Priority Setting Meeting Feedback Form. Giving Town and Parish Councils across NSK the opportunity to input into the Neighbourhood Policing Teams Priority Setting Meetings. These Meetings are held quarterly, where the Force, and Partners including The Office of Police and Crime Commissioner and Council representatives discuss the ongoing issues in line with crime stats from the local area and determine the priorities to focus resources. These Priorities then inform engagement in the local areas.

In the launch of the PSM Feedback Form, there are only a few priorities for each Neighbourhood Policing Area so not every concern sent in by Parishes will become a priority, but they will play a large part in the decision making for each Area.

We want to thank those Parish and Town Councils who have been returning the Feedback Forms and show the Community that we are listening to your concerns, and we are taking action, where possible. We encourage all Parish/ Town Councils to fill out and return the form, so we can hear the voices of the Community.

Neighbourhood Policing Teams (NPT) Q1 Priorities (Jan-Mar):

Grantham Neighbourhood Policing Area

Priority 1: Speeding

This was raised on several of the Feedback Forms including: Barrowby, Colsterworth, Great Gonerby, Dry Dodington and Corby Glen.

Across the quarter there were multiple Speed Checks completed by the Neighbourhood Policing Team, roads Policing Unit and the Special Constabulary.

7 Patrols were completed across the neighbourhood policing areas, specifically targeting those areas which raised priorities in their feedback.

- 13 Warnings were given.
- 3 Traffic Offenses.
- 1 Summons.

Priority 2a: Anti-Social Behaviour

Again, this was a priority chosen due to increased reporting, as well as feedback from Parish and Town Councils using the form.

ASB was Highlighted as a priority in these areas: Harrowby Estate, Riverside Flats, Barrowby Village Green and High Street.





Regular Patrols were completed over the course of the quarter. There were no issues or concerns to raise at Barrowby or the Harrowby Estate.

There are still issues which remain in the town centre. The NPT are working in conjunction with South Kesteven District Council, to target specific areas.

Priority 2b: Vehicle Anti-Social Behaviour

Specific areas of Vehicle ASB were raised for Twyford Woods, Alma Park and multiple Public Car Parks across the NPT Areas.

Multiple Patrols were conducted, appropriate action was taken at the time of Patrols. There have since been no current concerns raised, and no recent reports of Vehicle ASB.

Stamford Bourne and Deepings Neighbourhood Policing Area

<u>Priority 1: Seasonal offences of purse thefts, recent increase in high value shop thefts and increase in begging</u>

This priority was chosen due to the increased in reporting of these offense. Mainly in the Stamford Area.

Foot Patrols were completed by the NPT as well as partnership working with, South Kesteven District Council Housing Team, Royal British Legion and SSAFA (Soldiers', Sailors', and Airmen's Families Association) to support the multiagency approach to helping the Homeless people.

The NPT also did multiple engagements with the public, including the use of the Forces Engagement Cards as well as working with Shops and CCTV.

The positive action by the NPT and other agencies, along with a media post in the Stamford Mercury has lead to a reduction in offending.



Priority 2: Anti-Social Behaviour

Woody Heights was specifically mentioned as an area of high ASB. Multiple High vis patrols were completed by NPT conducted-often. There were often no persons present or a small gathering of young people on their mobile phones. No offences have come to light on engagement.

The increased Patrols may have been a factor in the reduction of ASB. This area along with other will be continued to be monitored as we enter the summer months.

Speeding

Although speeding wasn't chosen as a priority for Q1 it was raised by multiple Parish/ Town Councils.

Speed checks were completed by the Roads Policing Unit (RPU) throughout the previous quarter with outcomes.

- Cherry Holt Road, Bourne 08/02/23
- A6121 Stamford fitness 16/01/23
- A15 Morton 09/01/23

There were 6 offenses for excess speed as well a 1 vehicle which had no MOT.

The RPU also conducted checks around Bourne during the times where students are leaving school to attend McDonalds.
